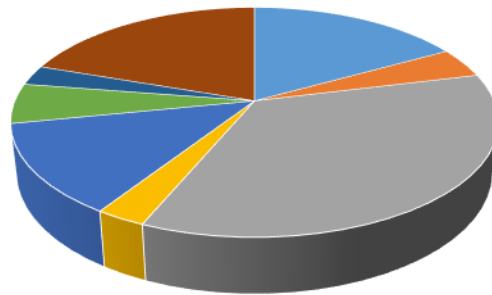
The chart of types of companies and organizations where internship of students of College ESLG was held is presented below in Figure 1.
