The present members of Study Commission unanimously voted in favor of approval of requests from 1 to 17 based on the following legal provisions:

1. Members of Study Commission voted in favor of approval of requests 1, 2, 4, 6, 7, 8, 10, 11, 15, 17 based on the following justification that Article 13 paragraph 6 of Regulation on Admission and Transfer to Master Studies of College ESLG provides for this and Articles 4 and 5 of the Administrative Directive of MEST 11/2015 on Equivalency of study programs completed in Pre-Bologna system establish equivalency of pre-Bologna 5 year and 4 year studies to 300 ECTS and 240 ECTS credits respectively;
2. Members of Study Commission voted in favor of approval of requests 3 and 5 based on Article 11 of Study Regulation, which provides that students who have above-average success during two first year of studies have the right to faster advancement and proposed the Senate of College ESLG approval of faster advancement;
3. Members of Study Commission voted in favor of approval of requests 13, 14 pursuant to Article 13 paragraph 2 of Regulation on Admission and Transfer to Master Studies, which allows the Study Commission to review the courses requested for recognition and their curricula and decide accordingly. In this case Study Commission decided to recognize 60 ECTS credits in the case of request under 13 and 30 ECTS in the case of request under point 14;
4. Members of Study Commission voted in favor of approval of requests under points 9, 12 and 16 pursuant to Article 14 of Regulation on Admission and Transfer to Bachelor Studies, which enables the Study Commission to review the courses and curricula of the courses requested for recognition, which Study Commission did so accordingly in the preparation for the present meeting and decided to recognize 90 ECTS credits for cases under points 9 and 12 and 46 ECTS credits for the petitioner under point 16;
