

Pursuant to Article 16 paragraph 2 of the Statute of College ESLG, the Management Board of College ESLG adopts the following:

REGULATION ON THE FUNCTIONING OF ALUMNI CLUB OF COLLEGE ESLG

Article 1

These rules govern the operations of the College ESLG Alumni Club.

Article 2

The ESLG Alumni Club is an internal organizational unit of the College ESLG (hereinafter referred to as the College), which aims at preserving and strengthening contacts between the graduates and the College in all socially beneficial areas.

Article 3

The ESLG Alumni Club is not a legal person. It can carry out its activities, rights and obligations only under the authority of the Management Board of the College.

Article 4

In the annual financial plan, the College provides for resources, from which the activities of the ESLG Alumni Club are financed.

The resources for carrying out the activities from the preceding paragraph shall be obtained from membership fees, donations and with other legal methods.

For transparent operation of the ESLG Alumni Club, the College keeps the activities of the ESLG Alumni Club separate from the other activities of the Faculty in terms of organization and costs.

Article 4

After a successful defence of the diploma thesis, every graduate of any generation of ESLG's study programme shall become a member of the ESLG Alumni Club.

Every member may withdraw from the ESLG Alumni Club at any time by completing the declaration of withdrawal and submit it to the responsible person of the ESLG Career Centre in person or via the Internet.

Article 5

The ESLG Alumni Club has the following bodies: The President, the Council, the General Assembly and the Secretary.

Article 6

The President represents the ESLG Alumni Club outside the Faculty and in relation to the College. The College Management Board names the President for the period of four years, after consulting with the ESLG Alumni Club Council.

Article 7

The ESLG Alumni Club Council consists of three members that are elected by the General Assembly at the proposal of the President of the Alumni Club by a majority of votes for the period of four years.

Article 8

The General Assembly of the ESLG Alumni Club consists of all the members of the ESLG Alumni Club. The President of the ESLG Alumni Club shall convene meetings of the General Assembly.

Article 9

The Secretary of the ESLG Alumni Club is the head of the ESLG Career Centre. The Secretary is named by the Management Board and reports to the Management Board regarding their duties. The Secretary of the ESLG Alumni Club shall attend meetings of

all the bodies of the ESLG Alumni Club and prepare reports about the meetings for the Rector of the College.

Article 10

The President of the ESLG Alumni Club manages the operations of the ESLG Alumni Club. In cooperation with the members of the Council, the President shall prepare an annual work plan. The Rector of the College shall vote on the annual work plan before confirming it.

Article 12

Membership in the ESLG Alumni Club requires the members to respect the goodwill of the Faculty and meet other obligations set out in these Rules. Membership in the ESLG Alumni Club brings the following benefits:

- invitations to regular annual meetings of the ESLG Alumni Club,
- invitations to events organized by the College Career Centre,
- invitations to ceremonial events of the College,
- information about conferences and other events in the College organization,
- participation in the development of College programmes,
- keeping in touch with the College after graduation,
- promotion of professional achievements of graduates and other.

Article 13

In its operations, the ESLG Alumni Club shall use the College symbols. It shall also be presented on the College website.
